2008 Mid-Central Conference on Problem Gambling - Completing the Cycle

As this newsletter written, planning is nearly complete for the 2008 Mid -Central Conference on Problem **Gambling**. This year's conference will be held on September 17, 18 and 19 at the newly remodeled **Drawbridge Inn at Fort Michell** Kentucky near Covington Kentucky and Cincinnati Ohio. Hotel rooms are \$75 plus applicable taxes. The registration cost will remain \$60 for members of the NCPG and its affiliates and \$90 for all others. Registration can be made at: ww.kycpg.org beginning on May 1. Financial support from the Indiana and Kentucky state governments allow the Alliance to keep the registration cost very affordable.

Expansion of Gambling?

Since this year's legislative session was the short session and the key issue was home owner property tax relief, we did not expect any legislation that would result in an expansion of legal gaming. We were mistaken. **House Bill 1153** allows Indiana taverns to sell pull tabs, punch boards and tip boards. The interesting story is now this came about at a time when we thought the main focus of the short, two month, legislative session would be property tax *(continued on page 2)*

relief given the political fallout around the state in last November's elections.

I will try to explain the chain of events and the "logic" behind this action. It will be easier to follow this if we take it step by step.

- In 2006 charitable gaming organizations were allowed to sell pull tabs, it isn't just bingo and raffles anymore. There are 2689 such organizations, a great many but not all of these sell pull tabs as well as alcohol.
- Last year legislation was passed that allowed each of the two central Indiana horse racing tracks to add 2,000 slot machines in 2008, if they paid a \$ 250,000,000 dollar fee to the state and shared the proceeds with the State. The tracks were each also required to contribute \$500,000 to the State's Problem Gamblers' Fund annually.

So that it could be said that this was not an expansion of gaming, a crack down on the many thousands of illegal "**Cherry Master**" video gambling machines accompanied this legislation. It was argued that there would be a net decrease in gambling if the highly addictive illegal video games were eliminated. These were in bars, truck stops, social clubs, home garages, etc. throughout the state.

3. The increased efforts to eliminate these illegal machines hurt many of the small taverns who relied on these illegal gambling proceeds to remain profitable. Because of this these taverns then found themselves to be at a competitive disadvantage with those charitable gaming organizations who could sell alcohol and pull tabs. It should be noted that some of these charitable gaming organizations previously had illegal video gaming machines too.

 The tavern owners successfully made their case to the Legislature that they needed help to compete and stay afloat. This help being pull tabs, punch and tip boards.

It is impossible to tell to what extent the "Cherry Master" machines have gone away because they were in so many places. Is this a reduction or an expansion of gambling? We don't know. There are several thousand taverns throughout the state. How many will choose to sell pull tabs? Again we don't know.

What we do know is that a small percentage of Hoosiers will become addicted to pull tabs. This is true of every type of gambling, illegal and legal, including bingo.

The Indiana Council exists to see that help is available for Hoosier problem gamblers and their families. To that end we testified before the committee considering this legislation. We asked that an annual fee be paid to the Indiana Problem Gamblers' Fund by each tavern selling pull tabs. We noted that this was required of the casinos and race tracks. We noted that the Legislature had set a precedent that all for profit entities engaged in gambling contributed to the fund and we did not want to see this good precedent lost. We failed in this effort.

We believe that the Legislature should not be selective with regard to who helps repair the lives that become damaged by state sanctioned gaming. We hope that this year's decision will not become a new and very poor precedent when the Legislature considers the next proposed expansion of gambling.

The Indiana Council is neither for nor against legal gambling. We do understand the need to find revenue to support the governmental services that we all want. We all desire to pay as little tax as possible for these government services. Nearly \$1 billion dollars will be paid to the Indiana General Fund this year as a result of legalized gaming in Indiana. Additionally, Indiana greatly benefits from the economic development and tourism associated with gaming. Because of this, legal gaming will continue to provide a painless solution for most of us, but not all of us. We hope our Legislature acts differently the next time.

Department of Corrections

In late 2007, **DOC Commissioner Donahue**, implemented an initiative that required all of Indiana's State correctional sites to address problem gambling. It was hoped that **Gamblers Anonymous** meetings could be held at each site. Making this happen was problematic. A check of the GA web site indicates that there are 24 GA meetings each week in Indiana. There are 36 DOC facilities. DOC contacted Gamblers Anonymous, the Division of Mental Health & Addiction, several of the PG treatment providers and the **Indiana Council**, looking for assistance with this project.

Given the small number of GA meetings in our state, the number and location of the DOC facilities and the restrictions required at DOC facilities; a creative solution was needed.

The Indiana Council sought and received assistance from the Indianapolis GA organization (www.indyga.org). On January 8, a workshop training session was held at Indianapolis for staff from each of the DOC facilities. Three Indy GA members, one of which is a ICPG board member, conducted this training. The goal was to train a staff member from each facility to lead a problem gambling support group. The meetings will not be GA meetings as they will not be lead by a GA member.

The meeting was very interesting in that the discussion made clear the limitations that must be imposed by the location of such meetings. Safety and security out weigh confidentiality in these support meetings.

The ICPG commends Commissioner Donahue for recognizing the need to address problem gambling in the DOC facilities and Gamblers Anonymous for assisting DOC in finding a way to facilitate the support meetings.

NPGAW March 9 –15

National Problem Gambling Awareness Week took place last week. The goal of NPGAW is to educate the general public and health care professionals about the warning signs of problem gambling and to raise awareness about the help that is available both locally and nationally.

Court Program Outreach

On February 28, George Brenner LCSW, LMFT, ICAC and a long time ICPG board member, presented a workshop titled "Basics of Problem and Pathological Gambling and Its Treatment" at the Annual Conference for Court Alcohol and Drug Programs sponsored by the Indiana Judicial Center. There are approximately 53 of these court programs in Indiana. More than 70 court program staff attended this event which was held in Indianapolis. Jane Seigle, executive director of the Indiana Judicial Center contacted the ICPG and the Indiana Council suggested George as the speaker on this issue.

The group was actively engaged in the presentation which included prevalence data, types of gaming, associated crimes, co -morbidity with other mental health and addictive disorders, treatment strategies, barriers to treatment, challenges in identifying problem gamblers and assessment tools that can be used to identify problem gamblers as well as other information on this subject.

One major area of concern of the attendees was that none of the court programs represented had even a basic gambling screening tool or questions as part of their formal assessment process. George suggested utilizing the lie/bet questions as a starting point in looking for a gambling problem when assessing court program clients. We think that this is an important first step with the court programs with regard to helping to get problem gamblers the treatment that they need for problem gambling.

Problem Gambling Work Group

The Division of Mental Health &

Addiction has established a work group which will examine the delivery of treatment services to problem gamblers. The group will also consider more intensive treatment regimens beyond outpatient counseling, the only state funded gambling treatment currently available. The group's first meeting was held on March 13 and there will be monthly meetings in the future to continue working on this project.

The work group includes staff from DMHA, the **Indiana Prevention Resource Center** and George Brenner and Jerry Long from the Indiana Council.
