September Conference

The Indiana Addiction Recovery Month Symposium/ MidCentral Alliance on Problem Gambling Conference will be held September 25 and 26 at the Indiana Government Center South Conference Center in downtown Indianapolis. Attendance is limited to about 350 due to the room size imposed by the location. There will be a full track on problem gambling. Jon Grant, JD, MD, MPH, professor Department of Psychiatry and Behavioral Neuroscience at the University of Chicago will join us again this year. Dr. Grant will discuss the impact and ramifications of the just released DSM-5 on the problem gambling treatment world.

Doug Stickney

Doug Stickney passed away on Sunday May 12 at Carmel Indiana. Doug founded the Custer Center for the treatment of problem gamblers at Indianapolis and Trimeridian Inc. at Carmel. He was a leader in addressing problem gambling.

Many of the most recognized names in problem gambling have been associated with Doug and these entities.

Doug, age 57, had a long list of accomplishments for someone so young. He will greatly be missed by all of those who were fortunate to know him.

2013 Indiana General Assembly Session

Hoosier Park Racing & Casino (Anderson) and Indiana Grand Casino (Shelbyville) had sought to add live table games like those at the eleven other casinos. The lack of this is the only real difference among Indiana's casinos beyond these two being non "boats." They both have electronic table games. It was said that approval would have led to the hiring of about 600 new employees. There are currently more than 12,500 casino employees. A sufficient number of the legislators considered this to be an expansion of gaming to deny legislative approval. Following the recent purchase of Indiana Grand, Indianapolis based Centaur Holdings now owns both of these properties.

The Indiana casino properties did succeed in gaining approval to deduct a portion of the free play dollars given to patrons prior to calculating the wagering taxes paid to the state so as to be better able to compete with the growing number of casinos in adjacent states. However, given the small dollar amount of this deduction, \$5 M/year for each property, it will not replace the revenue lost to nearby out of state casinos.

The taxes paid by the Indiana casinos has averaged more than \$800 M/year since the casino properties expanded to the current thirteen. When the State's share of the Hoosier Lottery revenue is added, more than \$1 B a year is paid to the State General Fund from gaming revenue.

The FSSA Division of Mental Health & Addiction State will have \$3,041,728 annually in State Fiscal Year 2014 and 2015 for problem gambling. This annual appropriation consists of \$2,572,675 for prevention measures and \$526,860 for research.

GTECH Now Manages the Hoosier Lottery

The State Lottery Commission entered into a fifteen year agreement with GTECH Indiana which will provide operational assistance with a commitment to increase Hoosier Lottery revenue of this period. This went into effect on February 1. Indiana is the second state to contract out management of their state lottery. Illinois was the first and is now managed by the Northstar Lottery Group, which is a consortium including GTECH Corporation and Scientific Games. Although not involved in the operational agreement in Indiana, Scientific Games continues to provide lottery machines and tickets for the Hoosier Lottery, as it has done in the past.

There has been criticism that the Hoosier Lottery's future growth in revenue will result in sales to those Hoosier's that can least afford to play the lottery economically will supply the sought after growth.

GTECH Indiana has created a position to address problem gambling. Katie Carlson is the Director of Corporate Social Responsibility and Compliance. Katie moved here from Rhode Island.

GTECH Indiana hosted a meeting on May 22nd for all of those Indiana organizations involved in oversight of problem gambling and providers of services to problem gamblers and their families. The purpose

of this meeting was to look for ways in which the Hoosier Lottery can address problem gambling.

Accreditation from the World Lottery Association will also be sought for the Hoosier Lottery. The WLA has developed responsible gaming compliance standards for its members. This accreditation is a multi-year process.

Katie Carlson has also joined the Indiana Council's board of directors.

All of this seems to be a very positive going forward.

Changes at the Indiana Casinos

Rising Star Casino has been purchased by Full House Resorts.

Centaur Holdings now owns both Hoosier Park Racing Casino and Indiana Grand Casino.

The former Aztar Indiana has been rebranded as Tropicana Evansville.

Pinnacle Entertainment, owner of Belterra Casino Resort, is in the process of acquiring Ameristar Casinos including Ameristar Casino Hotel East Chicago.

Four gaming companies will own two properties each when the Pinnacle acquisition of Ameristar is complete. Indiana statute limits ownership of gaming properties to no more than two by one company.

News from The Gambling Recovery Ministries

Major changes are occurring at the Gambling Recovery Ministries which was created by Reverend Janet Jacobs and her husband Ron in 2001 under the umbrella of the United Methodist Church (Southern Indiana Conference). The UMC will cease funding the GRM at the end of June. Reverend Jacobs will retire from the UMC at that time.

The Gambling Recovery Ministries will not disappear. Those of you who know Janet and Ron will know this. The GRM will continue under a new 501c3 as an independent ministry. The board will be drafting new bylaws and will continue to provide the great outreach that has been provided for the last twelve years. DSM-5 Questions

Under the DSM-4 pathological gambling was classified as an "Impulse-Control Disorder." Under the DSM-5 it falls under a category called "Addiction and Related Disorders." Will third party insurance now cover treatment costs? How will this effect the number of gamblers

entering treatment? Will more mental health/addiction treatment providers add problem gambling treatment to their services? Will this then result in a demand for more credentialed counselors?

Online Gambling

Last week U.S. Representative Peter King (R-NY) introduced the "Internet Gambling Regulation, Consumer Protection and Enforcement Act of 2013." The bill seeks to regulate online gambling at the federal level. All forms of online gambling, excluding sports betting, would be included. States and Indian tribes would have the option of opting out of this law if passed. States with regulation already in place would be "grandfathered" into the new system.

Legislation was previously introduced in 2011 to address this issue.

This legislation is broader than those introduced in the past. Rather than being directed only at online poker, it would also regulate online casinos and slots.
